WCS is excited to further our mission by implementing an innovative program at a new location called Bakari Center. Bakari, which means "noble promise," was intentionally chosen by WCS. This name reflects our promise to the community and the children that we serve to provide the highest quality services to meet the needs of each youth served at the Center. Bakari Center is a partnership with the Milwaukee County Division of Youth and Family Services to provide residential treatment services for boys ages 13 to 17 years old who are involved in the juvenile justice system. A third partner, Lad Lake, will provide clinical services for youth and their families. The partnership is focused on aiding youth in the community and as an alternative to placement in the Department of Corrections.

The programming offered at Bakari Center will focus on building from each of the youth's many strengths to support their growth and development. This innovative project will implement two evidence-based clinical approaches to support youth developing skills to reach their life goals. Bakari Center will be using an Integrated Treatment Model and Dialectical Behavioral Therapy will be the clinical component utilized within the programming to support youth and their families to develop skills to navigate adversity and life's challenges. WCS is committed to ensuring youth successfully transition back into their homes and communities following their stay at Bakari Center. A team of clinicians will engage the youth and their families in Multi-Systemic Therapy to provide comprehensive aftercare services. Family engagement and developing a strong support system around each youth will be a focus throughout the program. Bakari Center is scheduled to open later this year.

and Reintegration Services Administrator, accepted the award on behalf of WCS.




Share Your Heart!

The Community Development Block Grant Administration (CDBGA) Administrator, Steve Mahan, presented the award recognizing the valued relationship between the CDLRE and the Fatherhood Initiative. The CDLRE has been a supportive partner of the Fatherhood Initiative for over five

years, assisting young fathers to recover their driver's licenses so that they can support themselves, their families and their communities.

Career Opportunities at WCS

WCS is currently looking for energetic people to fill these positions:

Clinical Therapist

A clinical therapist is part of our new Residential Care Center program. This position is responsible for in-home individual counseling of residents and their families in planning, implementing, and coordinating services and resources. Applicants must have a master's degree in a social or behavioral science field and a minimum license of LCSW, LPC, or LMFT.

Certified Peer Specialist (CORE)

The peer support specialist provides support to youth and young adults who are being served by the CORE program. This position is responsible for providing support, education, and mentoring to all program participants. Applicants must be a graduate of state Certified Peer Specialist training and possess current certification.

<u>Case Manager (Milwaukee County Day Reporting Center)</u> Case managers provide supervision for adults referred to the program by the Milwaukee County House of Correction. They assess referred participants for eligibility using the LS-CMI and develop individual supervision plans. Case managers monitor all participant activity and progress with all service providers at the Reporting Center. Applicants should have prior experience with case management and a degree in criminal justice is preferred.
